### The Service

CGS CINS Master File with ISIN Linkage provides nine-character CINS (CUSIP International Numbers) mapped to their associated ISIN (International Securities Identification Number) as created by the respective National Numbering Agency. Included in the file are issuer and security descriptions and reference data for over 4 million securities (debt and equity) that trade globally and locally.

CINS are assigned to securities that are offered outside of the United States and Canada. The same Issuer (6 characters), Issue (2 characters) and check digit format used by the CUSIP Numbering System is used for CINS.

The first position of a CINS code is always represented by an alpha character, signifying the Issuer's country code (domicile) or geographic region:

A = Austria	G = United Kingdom	N = Netherlands	U = United States
B = Belgium	H = Switzerland	P = South America	V = Africa - Other
C = Canada	J = Japan	Q = Australia	W = Sweden
D = Germany	K = Denmark	R = Norway	X = Europe - Other
E = Spain	L = Luxembourg	S = South Africa	Y = Asia
F = France	M = Mid-East	T = Italy	Z = Indices
