### The Service

CUSIP Global Services (CGS) and Avox Limited have created an alliance to generate a universal identification system for global business entities called CABRE. CRIB utilizes the CABRE directory and Associated Issuer databases to identify the securities issued by a single entity historically through CUSIP related issuer and issue activity, such as name changes and numbering overflow. CRIB contains thousands of entity “bundles” linking the CABRE to that entity’s underlying CUSIP, CINS and ISIN, including matured and suspended issues.

### Benefits

- Link all securities issued by various iterations of a single entity
- 40 years of CUSIP related issuer and issue activity
- Added value to CGS’s contribution to the LEI
- Link an issuer to its short term issuance programs (e.g. Commercial Paper)
- Accurately identify exposure to a specific entity

### Features

- Over 110,000 Issuing Entity “Bundles” linked to over 8 million identifiers
- Mapping file containing CUSIP, CINS and ISIN identifiers linked to the CABRE
- Entity records are constantly monitored and updated based on expert analysis of daily updates from clients and partners
- All records are re-verified at least once within any 6-month period
- CUSIP Issuer number embedded in CABRE, if available
- Legal entity name as well as CUSIP issuer name is captured and displayed
- Historical names of companies at one point purchased by the surviving entity are displayed
