CGS CUSIP Access is a Web-based service that provides look up and download capabilities of the entire universe of CUSIP identifiers. The database contains issuer and issue identifiers, standardized descriptions and related data for more than 50 million U.S., Canadian and global unique financial instruments. The service includes up to 62 data elements and event-driven corporate actions such as name changes, mergers, acquisitions and reverse splits.

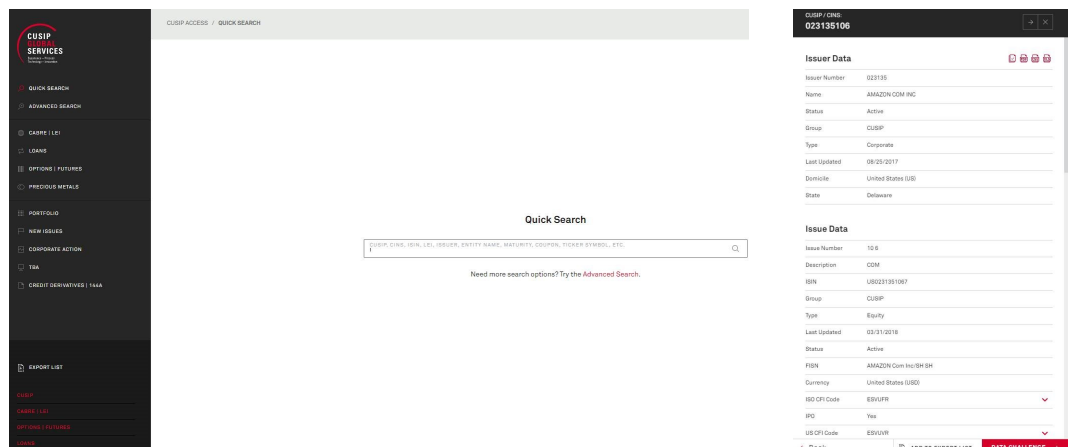
